AGENCY AGREEMENT, Tax Invoice and Debit Order

Agreement between the new agent(Reg/ID No) and recruiting agent (details above) and Kwikwap Mobile CC (Reg No CK08/158406/23) hereinafter called Kwikwap1 as well as the Licensor.

The new agent will hereinafter be called the Agent. The recruiting agent and Kwikwap Mobile CC will hereinafter collectively be called The Principals. The Agent shall not attempt to make any commitments, incur any liabilities or enter into any contracts on behalf of the Principals other than 1) recruiting new Agents based on this same agreement and 2) signing up customers under the "Website System Agreement".

Kwikwap1 hereby grants the Agent the rights to market and install Kwikwap website systems for customers for which the Agent is allowed to charge anything between **R0** and **R2,500, once-off**. These rights, embodied in an "agent code", cost **R171** per month (including VAT) plus a **R2,500** (incl VAT) **once off joining/training fee**. The Agent is also allowed to appoint other Agents and the recruiting Agent receives 100% of the joining fee (R2,500), in return the recruiting Agent must train the new Agent. The Agent may train more than one agent at a time. The Agent agrees to always conduct his business in an honest, ethical & professional manner. This agreement shall continue to be in effect for a minimum of three months where after 30 days written notice of cancellation can be given by either party. The Principals however retains the right to cancel this agreement with immediate effect if the Agent allow sites with sexually related content, profanity or otherwise improper sites and if the Agent does not adhere to the spirit of this agreement or neglect to collect debit orders from customers that paid a set-up fee. The R171 monthly agency fee may be deducted off from moneys due to the Agent in terms of this agreement. **The commission only accrues to the Agent once he has signed up 3 paying agents and/or clients.** The commission only accrues if the agent is **active**, which means his/her net number of clients (and/or agents) must **increase with at least one per month**. The Agent is only allowed to have five free active demo sites at any given time. a Free demo site may only be live for a maximum of two months.

This Agency agreement also entitles the Agent to earn the following monthly commission from each successful system sale: **R40pm** for system 1, **R49,50 pm** for system 2, **R75pm** for system 3, plus **R199pm** for each Support & Maintenance Contract as well as **R100pm** for each successful sub-agent that the Agent recruits and trains (these amounts include VAT if the sites and agents are in South Africa). The commission only accrues to the agent as long as the agent is willing and able to support his clients. These amounts are paid out net of bank charges (including clients' and own unpaid transaction fees) and agency fees 7 days after the debit order run. Kwikwap1 reserves the right to allocate a client to another Agent if the client submits a valid written complaint/request. The Agent is responsible that the customer and sub-agent's bank details are entered correctly in the system and that the Debit Order has been sent to Kwikwap1. A "Sale of a website" and the "appointment of a sub-agent" is only a successful sale (or appointment) if the debit order was paid, the client, Kwikwap1 (Kwikwap Mobile CC) is satisfied with the website, the Agent complies with this agreement and if the Debit Order has been sent through to Kwikwap1. The Agent is responsible for first line support to his clients or sub-agents. If the Agent has any technical or admin queries he should forthwith log these queries in the system where after Kwikwap1 will assist in due course.

These contract conditions are subject to change by Kwikwap1 and a copy of the latest agreement is available in the Agent's management portal. Kwikwap1 undertakes to inform the Agent via email of any changes and the Agent is bound by the new conditions. Kwikwap1 (Kwikwap Mobile CC) undertakes to be reasonable when amending the conditions.

Receipt of this instruction by you shall be regarded as receipt thereof by my/our bank.

Assignment: I/We acknowledge that the party hereby authorized to effect the drawing(s) against my/our account may not cede or assign any of its rights and that I/we may not delegate any of my/our obligations in terms of this contract/authority to any third party without prior written consent of the authorized party
