How does everyone make money?

From the outset the **KWIKWEB®** business model was built on the promise to be fair to everyone involved.

A **client** pays an initial fee of between R500 and R3,500 for the set up, training and design of a website. The client also pays between R59 and R150 per month for hosting, license fee and support.

The **web design consultant** earns the whole R 500 to R 3500 set-up and design fee, ensuring that he or she is well remunerated. The consultant also earns 50% of the monthly fee, paid by the client. The consultant is responsible for ongoing client support.

Consultants also have the option to work with our list of sales reps (sales agents) to find leads. The consultant and sales agent agree on the split of the setup fee.

The **license holder** earns 50% of the gross monthly fees of all the clients in his group less 6.5% royalties. He/she can also perform the duties of consultant, which will allow them to earn nearly 100% of the monthly fees.

KWIKWEB® Head Office earns a 6,5% royalty per month on all clients' monthly fees.

A candidate, that wants to become a consultant, has to be trained by an existing consultant or licensee. A few hundred **KWIKWEB®** training videos are also available on Youtube.

The training fee is R2,500 and is entirely distributed to the trainer (Consultant or Licensee).

A consultant must pay a monthly commitment fee of R150. The trainer earns R100 per month of this fee and the balance of R50 goes to the licensee. This system ensures continued support from the trainer as well as the license holder.

In summary, a consultant makes money from :

- Signing up new clients from R 500 to R 3500 for the webs design fee
- Signing up and training new consultants for R 2500
- Monthly commission of 50%
- Incentives; R 10 000 for every 15 clients

The consultants can generate sufficient income from the above methods, in order to do this work full time from the start. **Motivated and well-paid consultants are key to the licence holder's success.**

The consultants are responsible for first line of support and they only receive their commission if the client's payment was successful. The licensees are responsible for both collecting the money via debit order as well as for paying the consultants' monthly commission.

Consultants are very motivated with this model and are supported by comprehensive training and tools. Licensees earn repetitive lucrative revenue from the consultants' efforts, what will snowball eventually.

What is the difference between being a consultant and being a license holder?

A consultant only receives monies from his **own efforts** whilst a license holder receives monies from the **efforts** of all the **consultants in his network**. A license holder's network can quickly cover the whole country with numerous consultants, working for him or her.


