

PERMIT CODE OF CONDUCT

EL – MTB CLUB JOINT VENTURE

As a entry permit holder I agree to conduct myself in the following manner :

1. Ensure that you are in possession of a current valid permit issued as stipulated by your cycling club.
2. As a basic guideline in my activities as a permit holder, I will always treat others as I would have them treat me.
3. I will conduct myself in such a manner as to reflect only the highest standards of integrity, frankness and responsibility because I recognize that my conduct has far reaching effects toward all cyclists.
4. That I will display the utmost respect for the rules as set out by Landowners whilst on their property.
5. That if I should witness anything untoward whilst on the said Landowners property, I will report this soonest to the Landowner.
6. That if I should transgress from any of the above rules, that I will be held responsible for my actions and accept any sanctions set upon me by the Governing Club.
7. That if I should host any visitors who are not members of the EL – MTB Association, that I shall ensure that the same Code of Conduct as set for me shall apply to those visitors. Should the said visitors transgress whilst in my company, I will take full responsibility for their transgression.
8. Not act in any way that may infringe upon any of the terms or the substance of the Code of Conduct
9. Only use the marked routes.
10. Leave the property as it was found.
11. Ensure that every gate is left in the position in which it is found.
12. No littering
13. Immediately report any suspicious or illegal activities to landowner.
14. Notify your club should a cyclist make use the property without a valid permit
15. Strictly adhere to the permitted riding dates and times
16. By entering you agree you are familiar with the terms of the permit and that you do so at your own risk.
